For shipments that require BI to the agents ERTS facility the status 1 date will always be the date used to calculate storage. ** Charges will be calculated on the chargeable weight applicable to each Airwaybill (master and house) and are minimum charges which may be increased if additional work or expense is involved. The following charges apply to each Airwaybill master or HAWB or in instances where consignments are split for entry purposes. Import shipments may be check weighed or volume checked in the event of any discrepancies being found
